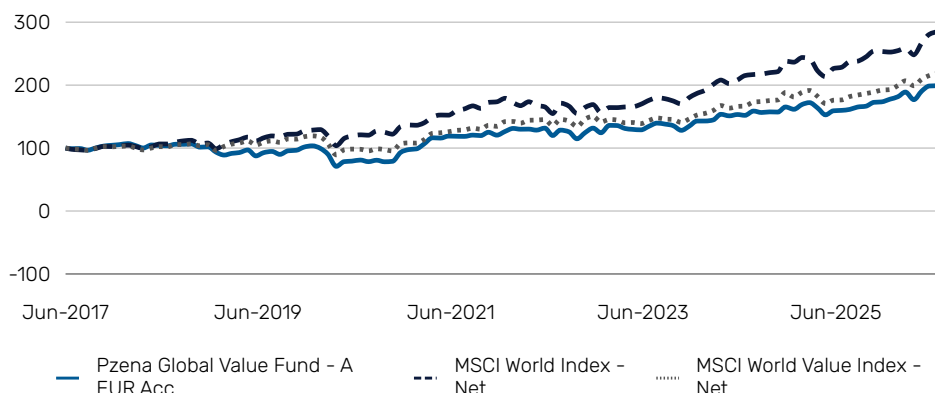

STRATEGY OVERVIEW

The information herein reflects the underlying holdings of the fund. Investors will acquire shares in the fund and will not invest directly in the underlying assets. Pzena actively manages the fund, employing a classic value investment philosophy. The firm seeks to buy good businesses at low prices, focusing on companies underperforming their historically demonstrated earnings power. The investment team performs fundamental research to determine whether the problems that caused the earnings shortfall are temporary or permanent. If a company meets the investment criteria after the in-depth research process is complete, the fund's portfolio managers determine through collaborative discussion and unanimous decision if the company should be included in the portfolio. Pzena integrates environmental, social and governance (ESG) considerations into its investment process, including assessing material ESG risk and opportunities as part of fundamental analysis and engaging with portfolio companies where relevant. The fund also discloses under Article 8 of SFDR, applies exclusionary screens, and manages to a carbon target.

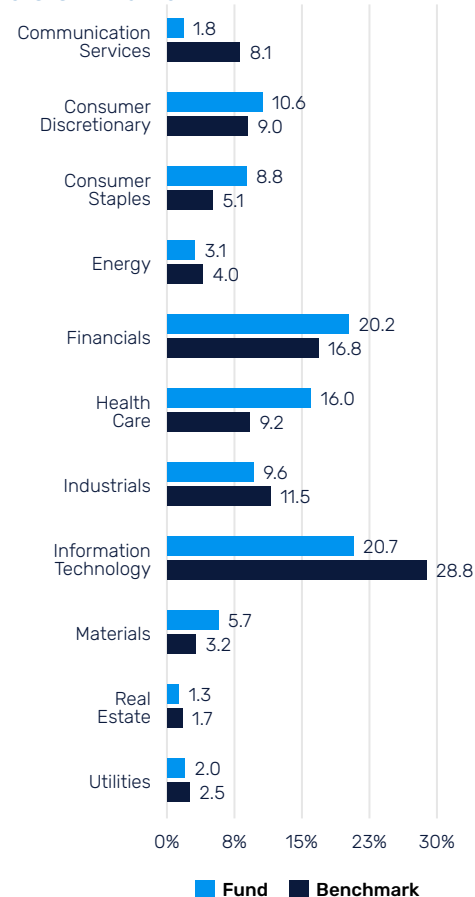

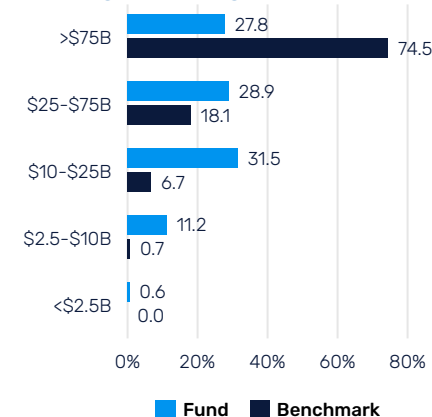

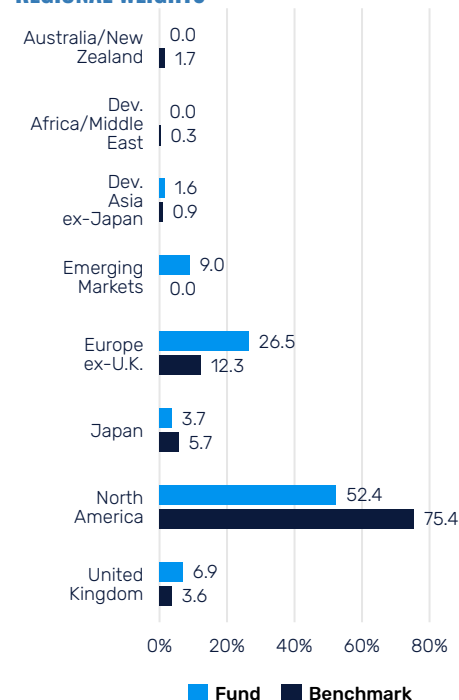
SECTOR WEIGHTS
